## I. 10.02(C) Project Description




Figure 1. Locus of Project Area in North Kingstown (not to scale).

The Quonset Development Corporation (QDC) is proposing to construct Phase 2 of Cross Park Avenue, a two-lane access roadway within the Quonset Business Park in North Kingstown, Rhode Island. Intended to improve vehicular circulation within the business park, the majority of this section of Cross Park Avenue utilizes existing roads within the park and runs north-south between Roger Williams Way and Callahan Road (approximately 0.5 miles), traversing through the North Kingstown Municipal Golf Course. The construction of this road will unify the Business Park's internal triangular roadway system of arterials as conceptualized in the Quonset Development Corporation's *Quonset Davisville Port and Commerce Park Master Plan, 2003 Revision*. Figures 1 and 2 depict the project locus and project overview respectively.
