Large scale plans, specifications and details are available at CRMC offices in Wakefield.

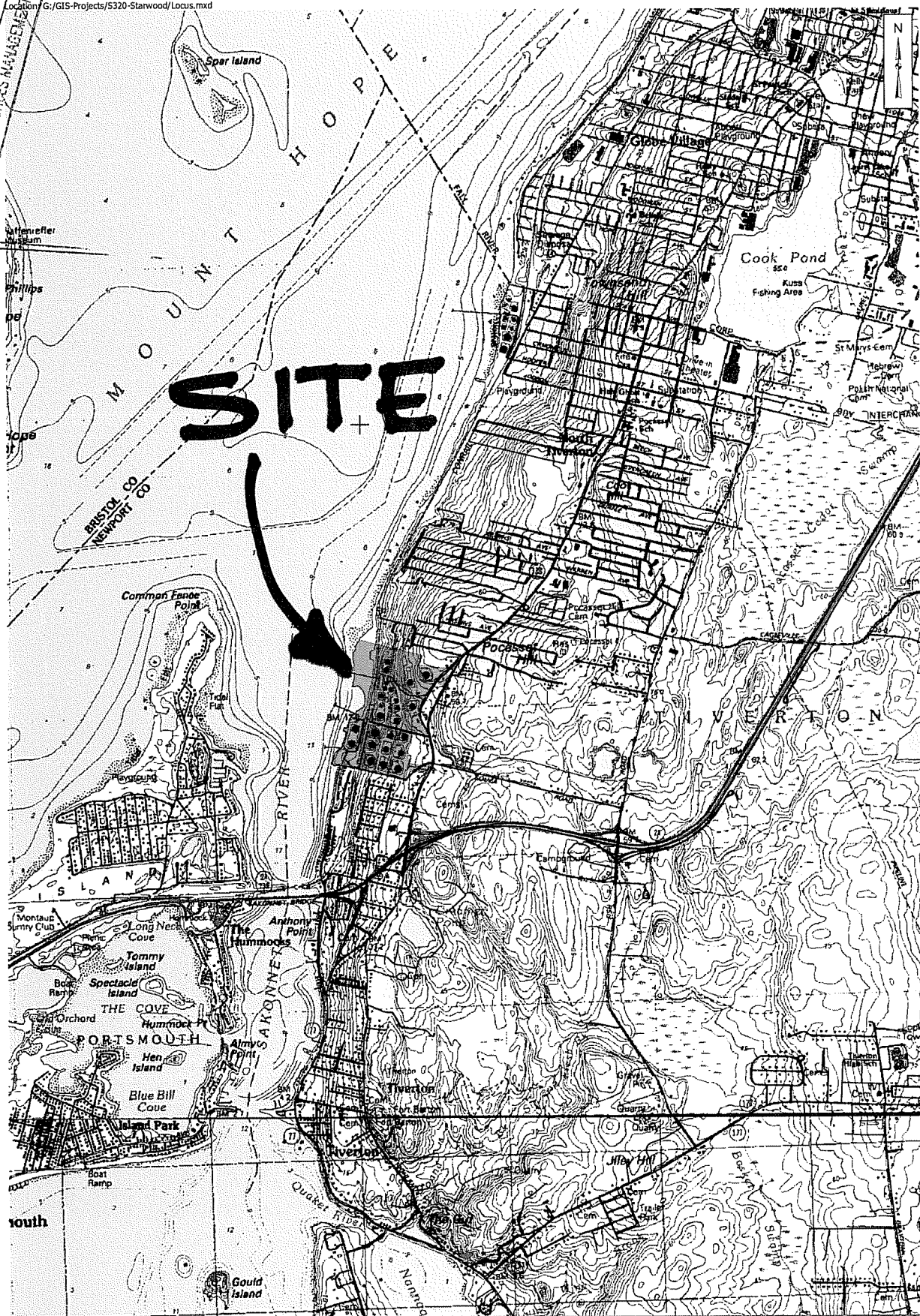

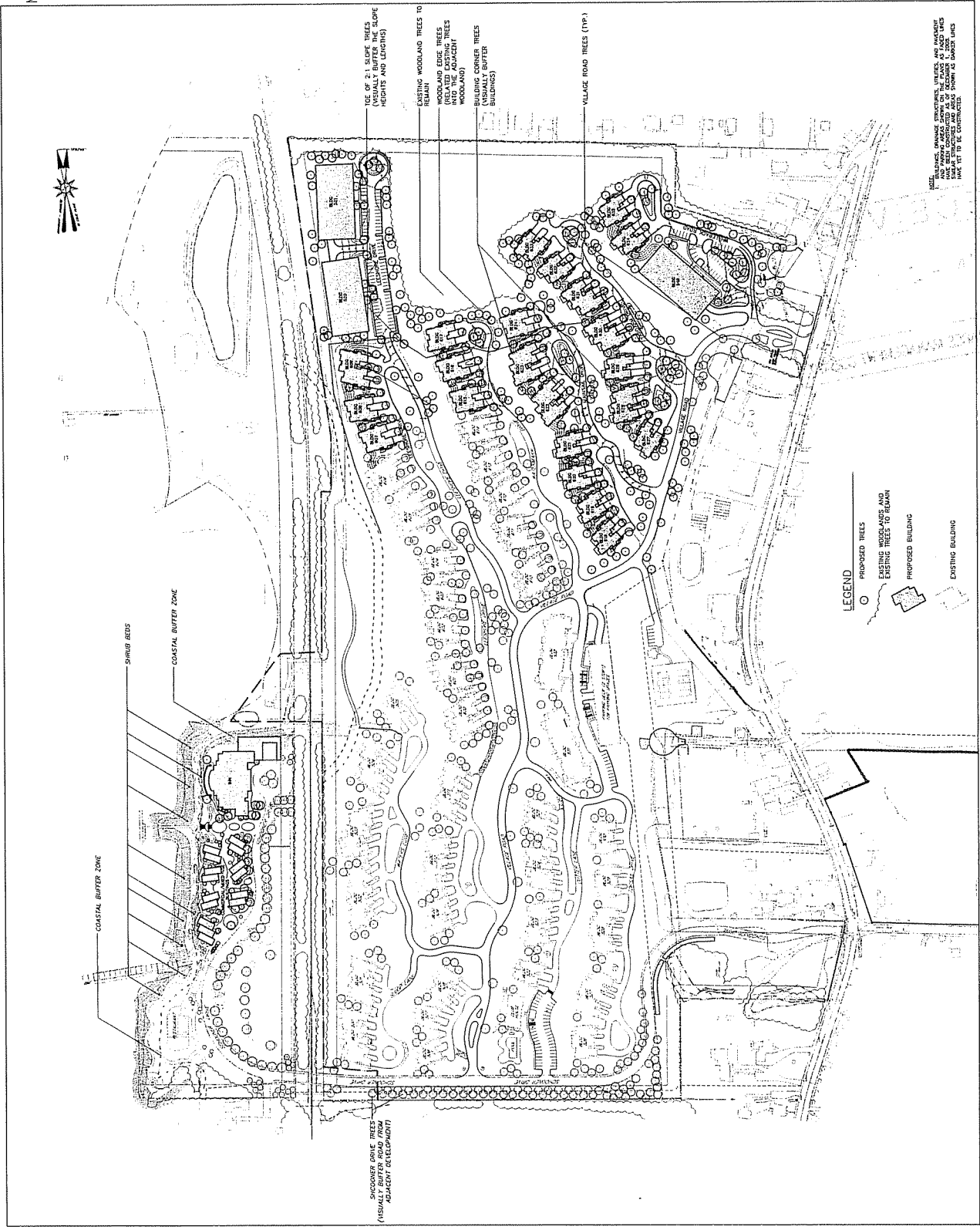

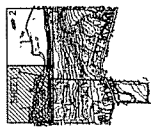

Keyplan

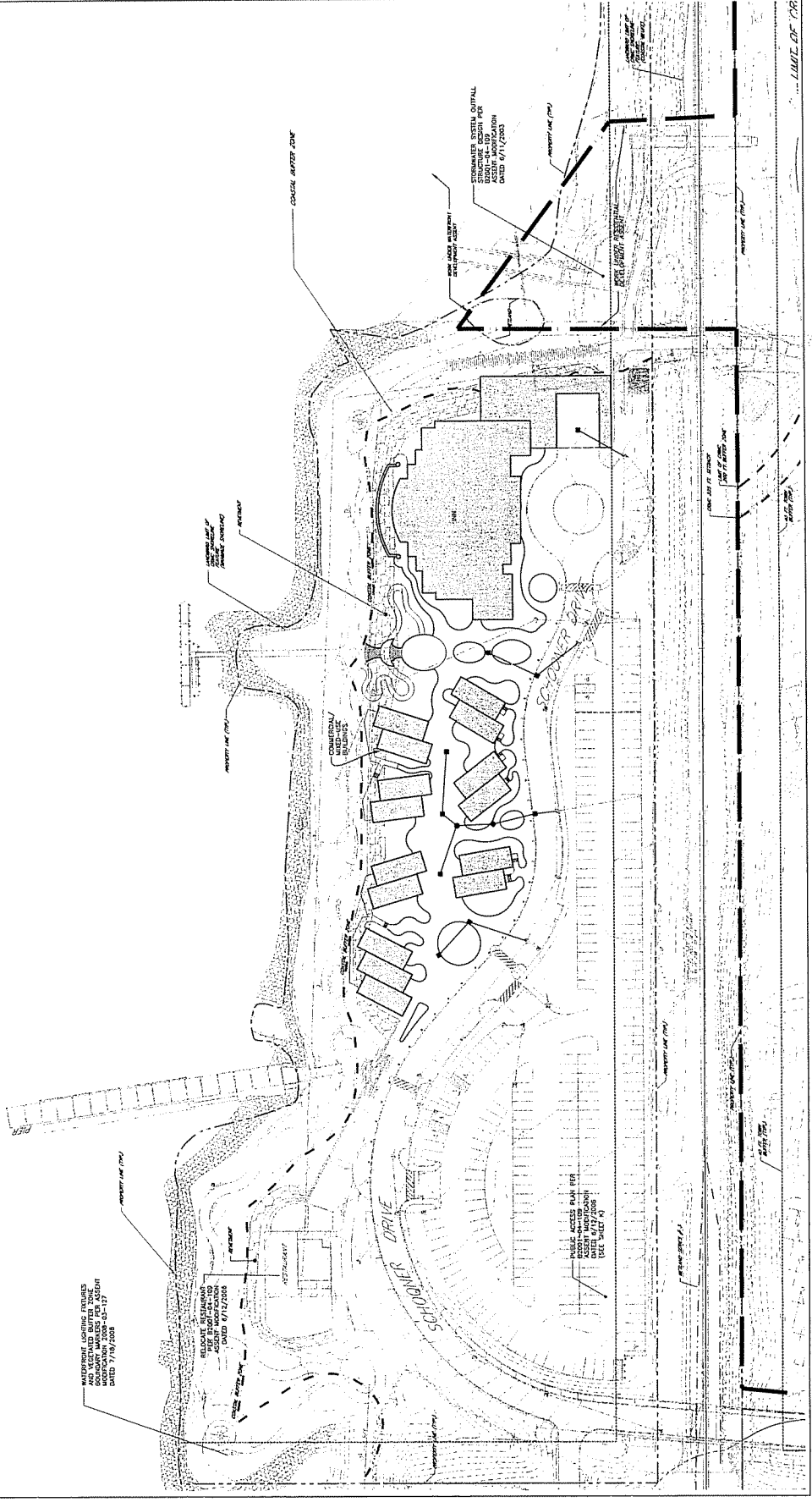


1. CHANGES REQUESTED BY CIVIL ENGINEER DURING PERMITTING PROCESS

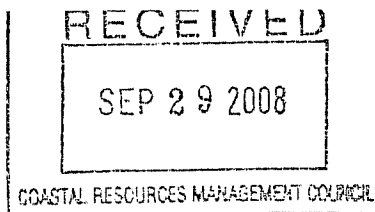
GRADING PLAN

1.0 PROJECT SUMMARY

Starwood Tiverton, LLC (Starwood) is submitting a Rhode Island Coastal Resources Management Council (CRMC) Category B Assent Application to receive approval to complete construction of the unfinished portions of the originally permitted project "The Villages on Mount Hope Bay" in Tiverton, Rhode Island (the Project) (CRMC Permit No. B01-04-109 [Residential] and B01-04-109 [Waterfront]).

The Villages on Mount Hope Bay involves the redevelopment of a 98.52-acre former Brownfield site located adjacent to Mount Hope Bay and on Main Road in Tiverton, Rhode Island (Figure 1). The Project is comprised of three distinct components: a 290-unit residential community; a commercial waterfront "village" inclusive of public access ways and other public amenities; and a sewer line extension connecting the site and certain neighboring land uses with the Fall River, Massachusetts Regional Waste Water Treatment Facility. The Project's residential component includes five phases as shown in Figure 2. Completed components of the Project include the following: the sewer line extension connecting the site and certain neighboring land uses with the Fall River, Massachusetts Regional Waste Water Treatment Facility; stormwater drainage; Phases I and II building construction (21 buildings/82 units) and landscaping; Phase III building construction (12 buildings/76 units); and Phase IV building construction (2 buildings/6 units), stormwater drainage, and landscaping. With the exception of the roof runoff, the majority of the stormwater drainage and landscaping associated with Phases IV and V is also complete. Section 0, Existing Site Conditions, provides additional details regarding the Project's completeness to date. The waterfront parcel infrastructure, Boat House Restaurant, common wharf, dinghy docks, mooring field, gazebo, and walking trails along the waterfront are 100% complete. The Public Access Plan approved by the original permit is also complete.

2.0 MARKET CONDITIONS

Since 2004, 164 units out of the total 290 units were constructed and 140 units were sold (45 units in 2004; 35 units in 2005; 27 units in 2006; 19 units in 2007 and 14 units to date in 2008). 126 units remain to be constructed out of the total 290 units in the residential development. Analogous to the current real estate market conditions in the Northeast, real estate sales of units slowed in 2006 and 2007. As a result, only six of the 57 units in Phase IV are planned for construction in 2008. The commercial waterfront development was also similarly delayed as a result of current market conditions. Only the boat house restaurant was completed among the 10 buildings in the commercial development. The decrease in expected sales and housing market conditions will result in The Villages on Mount Hope Bay requiring additional time before the Project reaches completion. Consequently, Starwood is seeking to obtain a CRMC Assent to complete the project in the next several years.

4.0 STORM WATER MANAGEMENT PLAN

In order to address CRMC's comment regarding updating the Storm Water Management Plan for Phases III, IV and V, a Revised HydroCAD Model for Phases III, IV, & V was completed and is included in Appendix B. The revised HydroCAD Model reflects the as-built condition of Basin 11 and the existing rim and invert elevations of the Basin 11 outlet control structure, northern diversion structure, and southern diversion structure.

The Basin 11 Flow Summary (Appendix B) was also updated to reflect the as-built information of Basin 11 (designed basin geometry is different from constructed). Please refer to the memorandum in Appendix B regarding the Basin 11 Flow Summary for further details.

The "sub-watershed" delineation plan entitled Developed Watershed Plan submitted as part of the Storm Water Management Plan dated August 20, 2004, has been updated to reflect the as-built geometry of Basin 11 and is included in Appendix B as Figure 1. The Developed Watershed Plan shows the southern side of "Basin 11" and all contributing drainage piping.

The elevations on the outlet control structure for Basin 11 were added to sheet C-10.5.

The drainage calculations for the waterfront commercial zone are included in the SWMP for Phases 1 and 2 that were part of submittal for the original permit.

The construction and infrastructure designed and permitted for Phases I and II is complete as shown on the existing conditions plan (Sheet C-4) and in the original SWMP for Phases I and II. Nothing that was constructed in Phases I and II is proposed for expansion.

Vortech unit sizing is addressed in the SWMP for Phases I and II. As stated in Section 2.0, the vortech units used for stormwater management on the waterfront were installed as part of the Phase I and II construction (and previously permitted).

5.0 UNDERDRAIN SEPARATION DESIGN

The original design of Basin 11 (as permitted under CRMC B2001-04-109 Assent Modification dated November 18, 2004) included routing of groundwater captured by the site's system of underdrains into Basin 11. CRMC has commented during recent site visits on the groundwater flow in this basin. In response, Starwood proposes an underdrain separation design to alleviate groundwater flow from the site's system of underdrains to Basin 11. Existing underdrains conveying groundwater to Basin 11 would be disconnected from the stormwater management system and diverted to a proposed drain line that will bypass Basin 11 and outlet to the northern diversion structure. This work would be performed as part of the site construction activities for Phases IV and V. The underdrain separation design is shown on Sheet C-10.5 of the revised Site Plans.
