for a State of Rhode Island Assent to construct and maintain: a recreational boating facility to consist of a 4' x 90' fixed pier, a 3' x 20' ramp and a 10' x 15' (150 square foot) float. The terminus of the dock extends to 75-feet beyond mean low water requiring a 25-foot variance and to a water depth of approximately minus two and a half (-2.5') feet. An outhaul will also be removed (see attached plans).

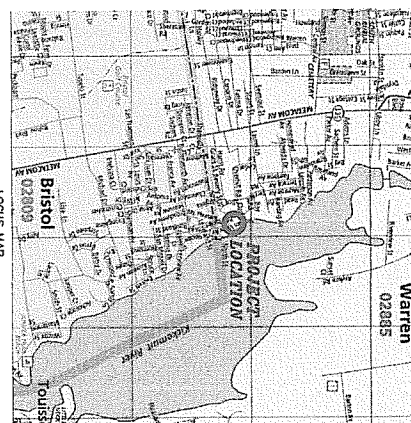
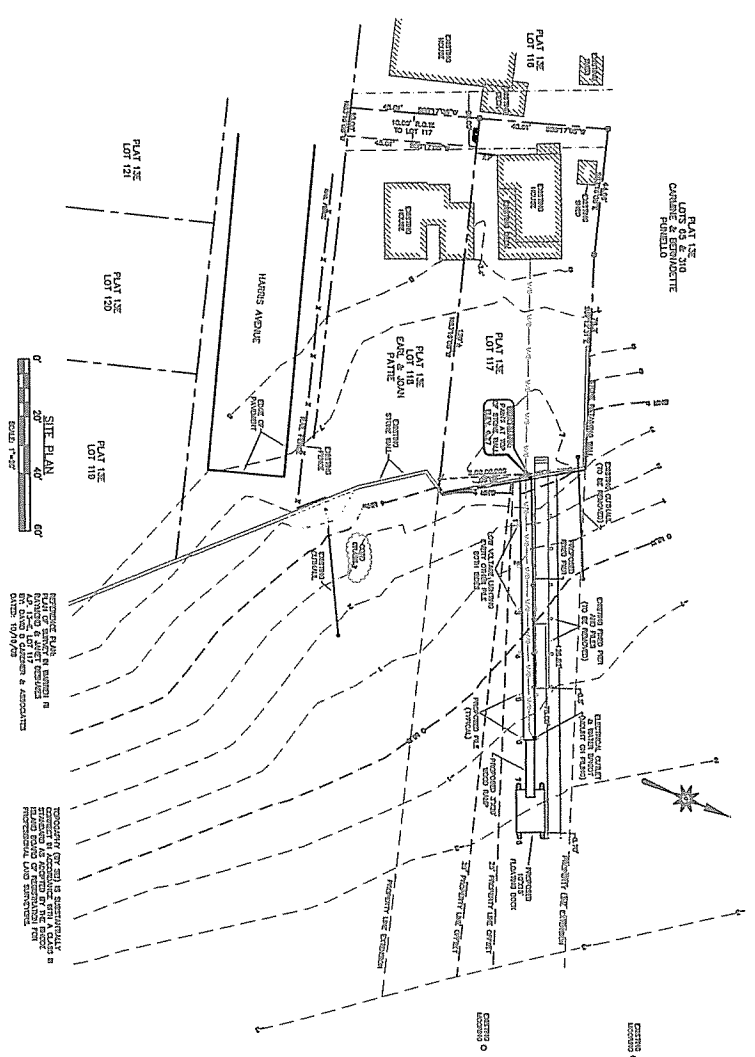

Plans of the proposed work may be seen at the CRMC office in Wakefield.

In accordance with the Administrative Procedures Act (Chapter 42-35 of the Rhode Island General Laws) you may request a hearing on this matter.

You are advised that if you have good reason to enter protests against the proposed work it is your privilege to do so. It is expected that objectors will review the application and plans thoroughly, visit site of proposed work if necessary, to familiarize themselves with the conditions and cite what law or laws, if any, would in their opinion be violated by the work proposed.

If you desire to protest, you must attend the scheduled hearing and give sworn testimony. A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing and be received at this office on or before March 28, 2009.

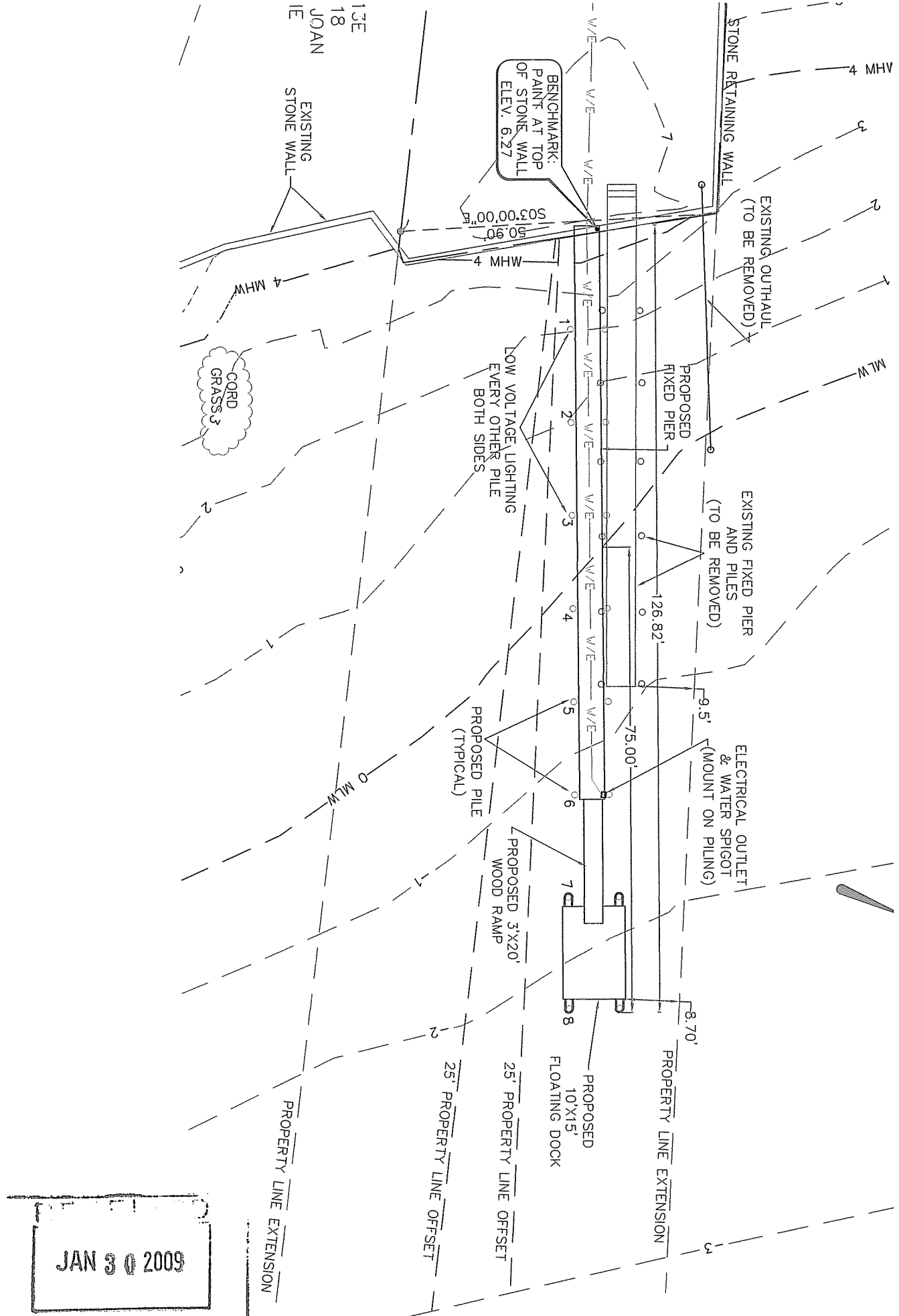

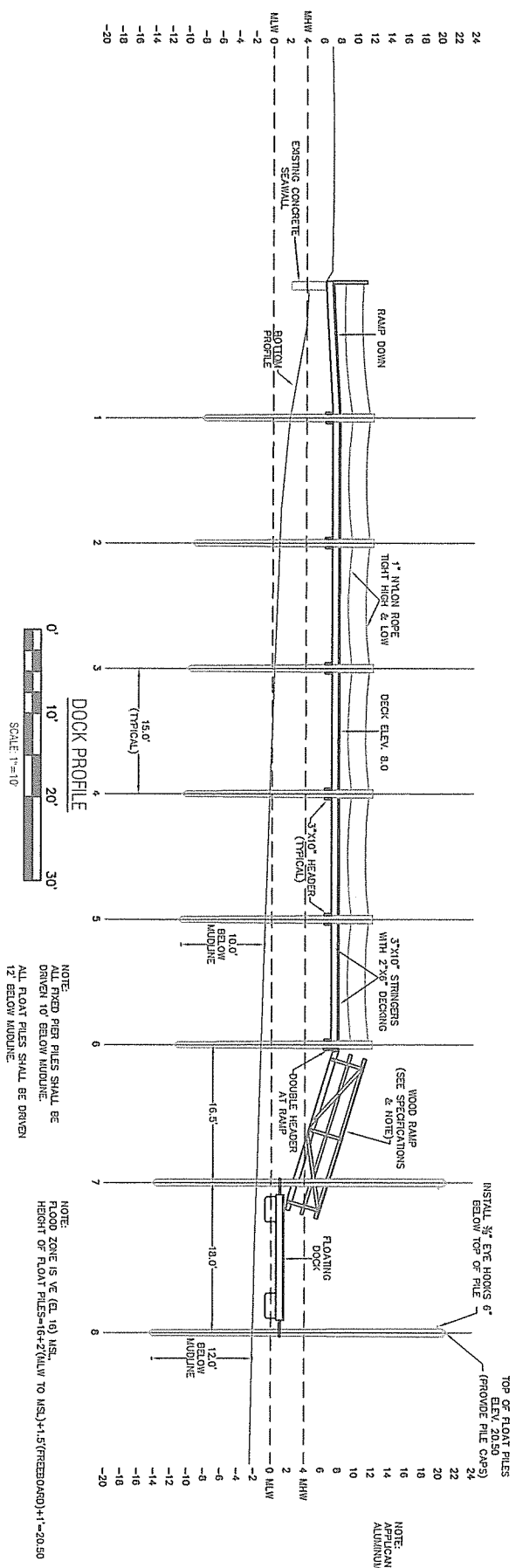
