for a State of Rhode Island Assent to construct and maintain: an expansion of the Fisherman's Memorial Campground. The applicant proposes to construct two graveled circulation rounds, twenty-two site suitable for recreational vehicles as well as six "hard[walled tents or cabins.

The proposed campground expansion is proposed within an area that was cleared of vegetation without the benefit of a CRMC Assent. The applicant proposed to allow those cleared areas that lie outside of the proposed development area to be allowed to revegetate naturally.

The project will require the issuance of Special exceptions to the Prohibitions contained in Section 920.1 of the Salt Ponds Region Special Area Management Plan which do not allow alterations within the mandatory buffer and setback areas.

In accordance with the Administrative Procedures Act (Chapter 42-35 of the Rhode Island General Laws) you may request a hearing on this matter.

You are advised that if you have good reason to enter protests against the proposed work it is your privilege to do so. It is expected that objectors will review the application and plans thoroughly, visit site of proposed work if necessary, to familiarize themselves with the conditions and cite what law or laws, if any, would in their opinion be violated by the work proposed.

If you desire to protest, you must attend the scheduled hearing and give sworn testimony. A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing and be received at this office on or before April 26, 2009.
