for a State of Rhode Island Assent to construct and maintain: a residential boating facility consisting of a 16' x 16' deck to a 4' x 130' fixed timber pier to a 3' x 28' ramp, to a 10' x 20' float. The facility will extend 74' beyond Mean Low Water to -7' depth. Additionally, a boat lift and a float lift are proposed. Variance to RICRMP Section 300.4.E.3(1) 50' standard beyond MLW (74' proposed) is required. Variance to RICRMP 300.4.E.3.(e) 150 s.f. standard for terminal float (200 s.f. proposed).

In accordance with the Administrative Procedures Act (Chapter 42-35 of the Rhode Island General Laws) you may request a hearing on this matter.

You are advised that if you have good reason to enter protests against the proposed work it is your privilege to do so. It is expected that objectors will review the application and plans thoroughly, visit site of proposed work if necessary, to familiarize themselves with the conditions and cite what law or laws, if any, would in their opinion be violated by the work proposed.

If you desire to protest, you must attend the scheduled hearing and give sworn testimony. A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing (with your correct mailing address and **e-mail address**) and be received at this office on or before March 2, 2011.
