for a State of Rhode Island Assent to construct and maintain: a residential boating facility. The facility will consist of a 4' x 12' approach ramp, 4' x 60' fixed timber pier, 3' x 16' ramp, and an 8' x 18.75' float. The facility will extend 74.8' beyond Mean Low Water to a water depth of approximately 2.7'. A variance to RICRMP 300.4.E.3.L is required (standard is 50' beyond Mean Low Water).

It is expected that objectors will review the application and plans thoroughly, visit site of proposed work if necessary, to familiarize themselves with the conditions and cite what law or laws, if any, would in their opinion be violated by the work proposed.

If you desire to protest, you must attend the scheduled hearing and give sworn testimony. A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing (with your correct mailing address, e-mail address and valid contact number) and be received at this office on or before December 26, 2012.




