for a State of Rhode Island Assent to construct and maintain: Phase IB of the Narragansett Roadway Improvement Program involves the reconstruction of Betty Drive, Raymond Drive, Island View Road, Houston Avenue, Cedar Island Road, Champlain Cove Road, and Flintstone Road. Drainage systems are proposed to be upgraded with new catchment and conveyance structures, and stormwater runoff is to be treated utilizing Dry Biofiltration Swales and Bioretention Basins.

Waterway:	Point Judith Pond/ Wesquage Pond

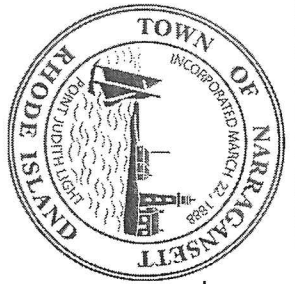
Plans of the proposed work may be seen at the CRMC office in Wakefield.

It is expected that objectors will review the application and plans thoroughly, visit site of proposed work if necessary, to familiarize themselves with the conditions and cite what law or laws, if any, would in their opinion be violated by the work proposed.

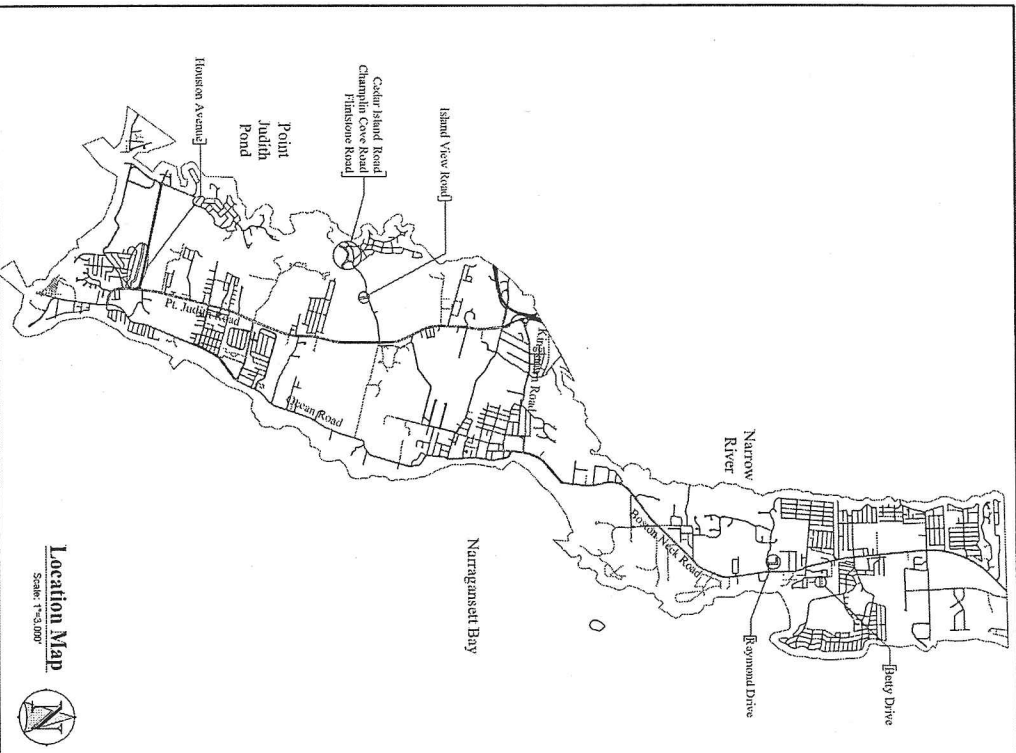

A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing (**with your correct mailing address, e-mail address and valid contact number**) and be received at this office on or before September 13, 2014.
