This office has under consideration the application of:

Kathy S. Mancosh 30 Angell Court Warwick, RI 02886

for a State of Rhode Island Assent to construct and maintain a 4 ft x 163.75 ft residential pier with 4 tie off piles. The dock is proposed in a high fetch area and is proposed to extend 75 ft seaward of mean low water (MLW) to achieve a water depth of 6.3 ft. Variances are requested from 300.4.B.2.d (boating facility shall be contiguous to a private residence); 300.4.E.3.1 (50' standard beyond MLW); and 300.16.F.3 (tie off piles within 25' extension of abutting property line).




Plans of the proposed work may be seen at the CRMC office in Wakefield.

In accordance with the Administrative Procedures Act (Chapter 42-35 of the Rhode Island General Laws) you may request a hearing on this matter.









PROFILE VIEW 1"=30"


B1 THRU B6 SOUTHERN YELLOW PINE (12-3-10) B7 THRU B14 GEENHEART PILES (14-3-10)








PROPOSED RESIDENTAIL PIER
