Club for a State of Rhode Island Assent to construct and maintain:

Modify existing recreational boating facility (CRMC Assent 2021-02-053) to provide more stable floats. The floats usage will remain as "touch and go" use and provide access for small crafts such as kayaks, sail and

paddle boards.

The above-referenced application was reviewed by the Conservation and Harbor Management Commissions at their joint meeting of July 14, 2022. There being no substantive objections to the application, the Commissions both voted unanimously to send a positive recommendation to the Town Council with the following condition for consideration.

The demolition plan submitted indicated that piles would either be cut off below marine bottom grade or completely removed. The commissions both recommend that the piles be completely removed rather than cut off below grade. This is consistent with the recommendation from the Deputy Director of Public Works (attached).

Conservation Commission Voting Members: Ahren Cohen, Amy Sonder, Janice McAleer and William Brownell (4-0).

Harbor Management Commission Voting Members: Barbara Ray, Keith Finck, Eric Collins and John Wilson (4-0).

It should be noted that the Deputy Director of Public Works also made note of two other issues to be considered related to the use of the town right-of-way for access and staging as well as their preference for site clean up and the use of turbidity fences.

The applicant also submitted a packet of materials at the meeting that is attached to this recommendation for your consideration.
