relative to Title 46, Chapter 23, of Section 6 A, B, C, D, E, Title 46 Chapter 23 Section 18(b), Title 46, Chapter 6, Section 1, Title 46, Chapter 6, Section 2 of the Rhode Island General Laws of 1956, as amended, for a State of Rhode Island Assent to: **To construct a roof over an existing deck located at the North Beach Clubhouse, which is currently serviced by a removable tent. The project requires the issuance of a Special Exception to RICR-Redbook-650-20-00-01 Sections 1.2.2(B)(1)(C)(3)(AA-BB) as well as Section 1.1.9 and Section 1.2.2(G) for new construction located within the dune setback on a moderately developed barrier beach.**


The hearing will be held at 6:00 p.m. on Tuesday, June 13, 2023, in Conference Room A, Administration Building, One Capitol Hill, Providence, RI.
