Dear All,

Thank you for sending over supporting documentation for you counter offer. After careful review Sunrise Wind is pleased to make the following changes to its compensatory mitigation offer.

- Addition of BOEM draft guidance loss percentages of 100%, 80%, 70%, 60%, 50% (Years 1-5), including application of "WHOI" economic multipliers (IMPLAN) on such amounts.
- Model correction from 2020 to 2023 base year.
- A per-day adjustment, up or down, to the direct compensation amount based on the actual days
  of active installation of the project during construction.

## **Compensatory Mitigation**

<u>Direct Compensation Fund</u> \$16,938,000

Provided as direct financial mitigation to Rhode Island fishermen, commercial and for hire charter, operating in the Sunrise Wind lease area and export cable area in federal waters.

Adjusted to 2023\$.

Assumes a 5% discount factor.

Coastal Community Fund \$300,000

Provided for the establishment of a Coastal Community Fund to benefit the fishing industry and Rhode Island's coastal communities through grants.

The Direct Compensation Fund and Coastal Community Fund would be established under the RI Fishermen's Future Viability Trust and claims processes managed by a third party Technical Assistance Provider.

Recreational Fishing Study \$50,000

Provided to fund a study to evaluate level and type of recreational fishing in the Sunrise Wind lease area up to 5 years.

Navigational Safety and Training \$333,333

Funds set aside for a voucher program to provide eligible fishermen with pulse compression radar systems and AIS transceivers. The program also provides for fishermen to attend a professional training program of their choice and participate in a session of Orsted's wind farm simulator.

Total compensation of \$17,621,333

## **Additional Mitigation Efforts**

In addition to comprehensive mitigation measures already taken by the Project, Sunrise Wind will agree to:

- permanently drop 3 WTG positions in the NW corner of the lease area to eliminate impacts to complex habitat,
- microsite around complex habitat to the extent practicable and within technical limitations/feasibility for WTG, IAC, and ECR, and
- provide electronic copies of its monthly discharge monitoring reports (plan to submit on a quarterly basis) and annual biological and thermal monitoring reports and corresponding data related to the OCS-DC under the EPA NPDES permit.
