Work includes installing geotextile reinforced mechanically stabilized earth slope (MSE) with dimensions of (horizontal to vertical). The MSE slope will present as a natural slope (i.e., no manmade structure will be visible) The design allows for implementing native vegetation combined with coir logs, jute mat reinforcement, will satisfy slope stability requirements, will restore the toe of the slope to its approximate historic position, and will provide the desired protection for Booth Avenue and its utilities. A riprap sill will be installed to provide erosion protection and additional habitat for marine fauna (a constructed marsh with an artificial sill to reduce potential future erosion). Other features include an infiltrating Best Management Practice (BMP) for stormwater management and the installation of a pocket park. A special exception is required for the construction of the shoreline protection along a Type 1 shoreline per RICMRP I. 3. I.G.3(a) (Shoreline Protection, Prohibitions).
