Dear Ms. Byrne:

The Rhode Island Historical Preservation and Heritage Commission (RIHPHC) staff has reviewed the recommendation of effect for the replacement of Nonquit Pond Bridge no.292. The project scope includes installing a new bridge which is to include: concrete abutments, wingwalls, and pile caps, steel micropiles, approach slabs, rehabilitation of existing reinforced concrete abutments and wingwalls, elastomeric bearings, and prestressed concrete NEXT D beams. With associated wearing surfaces, pavement markings, curbs, and relocated utilities.

The Rhode Island Department of Transportation (RIDOT) has previously identified the Nonquit Pond Bridge No.292 and Rhode Island Archaeological Site 2815 within the Area of Potential Effect (APE). RIDOT has opined that the project will have an Adverse Effect on the Nonquit Pond Bridge and No Adverse Effect on Rhode Island Archaeological Site 2815. The RIHPHC concurs with this assessment of effects. RIDOT notes A Memorandum of Agreement (MOA) will be drafted for the project per request of the RIHPHC in an earlier project correspondence dated December 30, 2020. We look forward to continued consultation as the project and MOA advances.
