- A modification to an existing residential boating facility “CRMC Assent: 1996-02-070”, the proposed facility consists of a 4-foot-wide, 25-foot-long fixed pier, 16-foot aluminum access ramp and a 10’x15’ terminal float. The facility is proposed to extend approximately 25 feet beyond mean low water with a depth of 24 inches. No variances are required.

It is expected that objectors will review the application and plans thoroughly, visit site of proposed work if necessary, to familiarize themselves with the conditions and cite what law or laws, if any, would in their opinion be violated by the work proposed.

If you desire to protest, you must attend the scheduled hearing and give sworn testimony. A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing (**with your correct mailing address, e-mail address and valid contact number**) and be received at this office on or before February 22, 2024.

4. Deck load carrying capacity to be greater than 40 pounds per square foot or a 400 pound concentrated live load




Replacement of existing dock






Polystyrene filled polyethylene casings (closed cells)
Follansbee Dock Systems
floats or equiv. cells to support 4,500 pounds uniformly

use 8 PF-Ct 2 ft x 4 ft. poly floats (700 lbs capacity
