for a State of Rhode Island Assent to construct and maintain:

A 136'residential boating facility consisting of stairs leading to a 4'x 95'fixed pier, 3'x20' aluminum ramp, and 10'x20' terminal float in a high fetch location. The facility is proposed to extend 75' past mean low water requiring a 25'variance from the 50' length standard, Redbook section 1.3.1(D)(11)(1). The facility is located within the 25' setback from the property line extension and a letter of no objection was provided from the affected property owner.

In accordance with the Administrative Procedures Act (Chapter 42-35 of the Rhode Island General Laws) you may request a hearing on this matter.



If you desire to protest, you must attend the scheduled hearing and give sworn testimony. A notice of the time and place of such hearing will be furnished you as soon as possible after receipt of your request for hearing. If you desire to request a hearing, to receive consideration, it should be in writing (with your correct mailing address, e-mail address and valid contact number) and be received at this office on or before <u>April 30, 2025</u>.






