TOWN WHARF

Description:

Town Wharf is a wharf located at the end of Main Street in the Town of North Kingstown. It consists of a wharf facility jutting into Wickford Cove, on the westerly shore of Wickford Cove. It is known as Lot 257 on Plat 117 and consists of approximately Forty-Four Thousand Three Hundred (44300') square feet.

TITLE REPORT:

This is a wharf facility located at the end of Main Street, running from Main Street easterly into Wickford Cove.

The Town Council at a regular meeting held on March 13, 2000, a copy of which is attached, nominated and affirmed this as a right-of-way for designation as a public right-of-way to the tidal waters of Rhode Island, Town Wharf.

By letter dated December 4, 2001, a copy of which is attached, the Director of Public Works for the Town of North Kingstown indicates that this area is a Town owned facility and the Town assumes maintenance responsibility through the Public Works Department. The letter goes on to state that it insures public access, year-round and the proper maintenance of the infrastructure.

Further, the letter goes on to state that the Town has completed maintenance and improvements on this project.

Additionally, the property was conveyed by deed to the Town of North Kingstown by The Rodman Manufacturing Company on November 30, 1948, recorded on December 13, 1948 in Book 88, Page 39.

Based on the above recited facts, the undersigned believes that the site does constitute a public right-of-way to the shore of Wickford Cove.


