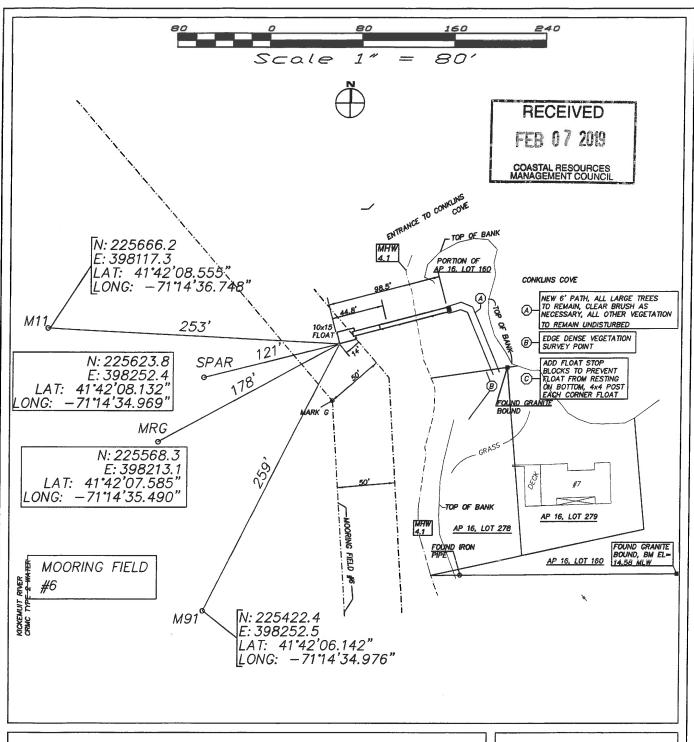

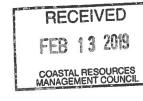

To whom it may concern:

I am writing the Council regarding file number: 2017-12-046, the application of James Barber of 7 Touisset Road, Warren, RI 02885, for a State of Rhode Island Assent to construct and maintain: a Residential Boating Facility on Plat 16 Lot 160 in the Kickemuit River.

In accordance with the Administrative Procedures Act, I am following-up on my previous request from January 26, 2018 for a hearing on this matter on behalf of myself and my fellow members of the Town of Warren Harbor Commission.

At our December 5, 2018 meeting Mr. Barber, his legal counsel and engineers met with the Warren Harbor Management Commission (WHMC) to review the proposal received by the CRMC on December 13, 2017. Additional documentation was provided that has been submitted to CRMC by the applicant on August 22, 2018.

Mr. Barber appeared with legal counsel for a second time at the January 2, 2019 WHMC meeting seeking a decision from the Commission on the revised proposal. While the new information provided in the revised proposal did not cause the Commission to revise our September 6, 2017 motion to disapprove the application, the Commission did make a motion to submit this follow-up letter to the CRMC to better outline our objections and concerns.

Public access to our shoreline and the proliferation of residential docks remain significant general concerns to this Commission. These concerns are outlined in section 2.3 of our pending December 2017 revision to our Harbor Management Plan and demonstrated by our extensive work with the CRMC to identifying and ensure access to all existing rights of way in town.

The specific objection to Mr. Barber's application is the encroachment of the proposed dock into the established mooring field. The consensus of the WHMC is that any variance granted for new dock construction would create precedence for future development and exacerbate the above stated

concerns of the WHMC limiting this Commission's ability to properly manage our anchorages and moorings as outlined in § 46-4-6.16 of the General Laws of Rhode Island.

The WHMC remains opposed to application 2017-12-046 as originally submitted on December 13, 2017 or as revised on August 22, 2018.

My contact information is listed above. I am again requesting notification once a hearing has been scheduled so I can forward that information to the remaining members of the Warren Harbor Commission so we may formally express our concerns to the Council.
