I have sent this message to provide you with my comments regarding the CRMC Draft Assent W2023-10-104 – Algonquin Gas Transmission LLC – Portsmouth

As someone who has spent much time and effort to get Rhode Island's ACT ON CLIMATE legislation passed and signed into law on April 14, 2021, I cannot stand by and let this project go forward without expressing my opposition. I strongly urge you to reject this project for the following reasons:

The purpose of the Act on Climate legislation is to reduce our state's collective carbon emissions to net-zero by 2050. We cannot do this if this project is approved.

It is obvious that there is deceit in Enbridge's stated objective for the project, which they claim is for the purpose of reliability, not additional capacity. By doubling the diameter of the pipeline, there would be an increase in its capacity by 300%, so the total amount of flow would be increased to four times the current capacity. Instead, they could increase the reliability of the pipeline, their stated objective, by re-lining the existing pipeline via a process known as Cured-In-Place-Lining (CIPL), which can line pipelines from 4" to 48" in diameter, creating a durable and impermeable composite pipe within the original pipeline without affecting flow capacity. This is what they should be doing.

Additionally, the proposed process for expansion of the pipeline - a mix of horizontal directional drilling for some segments and "cut and cover" for other segments - is very disruptive to the environment of the workspace. Horizontal directional drilling is often touted as much less disruptive, but can experience accidents through frac-outs, which leaks drilling mud into the environment. Notably, Enbridge has a bad record with Horizontal Directional Drilling. Enbridge's "Line 3", built in 2021, had 28 frac-outs when under construction.

To add to the potential negative impacts from such a project, The Sakonnet River is home to Sea Turtles, Atlantic Sturgeon and other threatened species. A frac-out could have disastrous impacts on their habitats

We <u>DO NOT NEED</u> extra capacity for natural gas. What we <u>DO NEED</u>, <u>desperately</u> <u>need</u>, is a massive transition to clean and renewable energy.

By allowing this project to move forward, you would be committing us to decades more of gas use, or stranded assets if the system becomes disused before its end of life. <u>This is not acceptable</u>.

I am submitting these comments in response to the permit application "2023-10-104", for the proposed expansion to the fracked-gas pipeline under the Sakonnet River.

This draft permit is contested, and the CRMC must host additional public meetings about it

Enbridge, through their subsidiary "Algonquin Gas Transmission" are proposing a pipeline expansion project which would involve doubling the size of their pipeline that runs under the Sakonnet River. This is a major infrastructure project that will impact a biodiverse and sensitive section of Rhode Island's waterways. The public should have additional opportunities to raise questions and concerns about this project.

In addition to the meeting scheduled on May 14th, an additional public hearing must be scheduled that is accessible to residents of Portsmouth, Little Compton, and Tiverton. The May 14th meeting is being held at a location an hour away from communities that would be impacted by the project. The meeting is being held at 6pm - which means that community members would have to drive over the Washington Bridge during rush hour traffic to attend. The timing and location of the meeting means that it would almost be impossible for working residents from Portsmouth, Little Compton and Tiverton to attend. Another public hearing must be scheduled.

Enbridge wants to use hazardous processes to install the expanded pipeline

Enbridge wants to install the expanded pipeline using a mix of horizontal directional drilling for some segments and "cut and cover" for other segments. Cut and cover is very disruptive to the environment of the work space. Horizontal directional drilling is often touted as much less disruptive, but can experience accidents through frac-outs, which leaks drilling mud into the environment.¹ Enbridge has a bad record with Horizontal Directional Drilling. Enbridge's "Line 3", built in 2021, had 28 frac-outs when under construction.² The Sakonnet River is home to Sea

Turtles, Atlantic Sturgeon and other threatened species. A frac-out could have disastrous impacts on their habitats.

Installing a new pipeline under the Sakonnet River is a high environmental risk that should not be taken. Narragansett Bay needs to be protected, and this application must be rejected.

The project is unnecessary and is counter to Rhode Island's climate goals

There is no need for this new, larger pipeline. Enbridge claims that there are "anomalies" in the existing pipeline that necessitate it. Re-lining the existing pipeline could be an option to repair it, especially since Enbridge has stated that more capacity is not needed. This wouldn't require any trenching or horizontal directional drilling and would involve far lower risk.

Cured-In-Place-Lining (CIPL), The PPM Starline® CIPL system can line pipelines from 4" to 48" in diameter, creating a durable and impermeable composite pipe within the original pipeline without affecting flow capacity. Ideal for midstream and upstream pipeline sector applications for systems operating between 0-350 psi to eliminate inadvertent emission of un-odorized natural gas releases due to leaks and resultant GHG issues.³ A study on this coating system was done at Cornell University that simulated 100 years' wear with no leaks.⁴ This alternative process for coating the pipeline must be explored and prioritized over dangerous and reckless practices such as horizontal directional drilling.

Furthermore, the 2021 Act on Climate mandates that Rhode Island reduce greenhouse gas emissions by 45% by 2030, 80% by 2040, and reach net zero by 2050. In January 2020, an Executive Order was signed for advancing a 100% renewable electricity future for Rhode Island by 2030. In 2022, the General Assembly enacted a Renewable Energy Standard of 100% by 2033. Expanding fracked-gas infrastructure is not compatible with these climate goals. Because of this, the application to expand the pipeline under the Sakonnet River must be rejected.

Overall, this project is unnecessary, dangerous, would negatively impact critical habitats, and runs counter to Rhode Island's emission reduction goals. CRMC must reject this application, and at the very least schedule an in person public hearing that is accessible to the residents who would be most impacted by the project.

My name is Susan Kelley, and I own property on Sakonnet Point, Little Compton, RI, which overlooks the Sakonnet River and Lloyd's Beach.

My income depends upon the river being clean and the beach being clean. I will never agree to approve the expansion of the Algonquin pipeline that currently runs in the Sakonnet River.

I take this position for many reasons. First of all, we are in a rapidly worsening climate crisis. Each winter, the storms become more violent with effects that are increasingly destructive. Lloyd's beach has been shortened by at least a mile in my lifetime, with rocks from each subsequent storm landing farther and farther inland. As the earth continues to heat up and the oceans have no way to cool themselves, storms and associated winds and waves will become more extreme, creating more and more havoc.

Rhode Island itself depends upon tourism dollars that arrive when people visit our great beaches. What will happen when those beaches are no longer so great? You and I know that time is coming. We have to work on mitigating climate chaos where and how we can.

Oil, gas, and coal are the clear causes of our heating planet. To save ourselves and our children, we must do our best to stop using fossil fuels, not limply comply with every request for expansion. We have to cut back. One way to do that would be to deny permission to Enbridge to expand the girth of the Sakonnet River pipeline.

Enbridge, owner of the Algonquin Gas Transmission system, claims the purpose of this project is increased reliability, but doubling the diameter of a pipeline increases its capacity by nearly 400%. We do not need increased fossil fuel capacity in Rhode Island, but the opposite. If needed, lower risk repair, such as re-lining of the existing pipeline should be pursued, rather than expansion.

Installing a new pipeline under the river is an environmental risk that is not warranted, given the need to transition away from fossil fuels. Enbridge has a bad record with horizontal directional drilling. Its Line 3, built in 2021, had 28 frac-outs when under construction.

It is crucial for Rhode Island, as for the entire world, to be transitioning away from fossil fuels at this time. The last thing any of us need is more non-renewable energy.

The net zero emissions goals of Rhode Island must be honored and taken seriously.

To whom it may concern:

As a Field Organizer for the Sierra Club, an organization that has thousands of members in Rhode Island, I am writing to formally object to the application numbered 2023-10-104. The basis of this objection is CRMC's failure to respond to communications related to this application, and failure to answer - or acknowledge - questions related to the process for filing an objection to this application.

This draft application should not be turned into a full Assent. More time must be granted for public comment, and a public hearing for the application must be scheduled.

Timeline of communications (copies of these email communications are attached):

- On February 14th I called CRMC and asked for a copy of this application. I then sent a follow up email that same day in which I asked for the application and asked what the process was for objecting. I received no response.
- On March 6th I sent up a follow up email reiterating these requests. I received no response.
- On March 11th I wrote to CRMC and asked what the process for filing a formal objection was, and how to submit
 public comment. CRMC staff finally provided me with a copy of the application, but I did not receive any
 information about submitting public comment or filing an objection.
- On March 12th I once again asked what the process was to file an objection. I received no response.
- On March 25th I called CRMC, at which point Amy Silva responded to me about the objection process.
- On March 25th I asked what the timeline for submitting objections was. Amy Silva responded to me today to tell me that this was the last day to file an objection. This was the first time I heard about this deadline, and it was shared with me just hours before objections are due.

Denying access to the application in a reasonable and timely fashion, and failing to provide any information about the process for filing an objection has denied myself, and Sierra Club's members in Rhode Island, an opportunity to adequately review the application and file detailed objections.

In order to address this harm, and create a fair, transparent process for this application CRMC should:

- Extend the deadline for submitting objections by 30 days.
- Schedule a time for CRMC staff to meet with myself, and other Sierra Club staff and Sierra Club legal counsel to review processes related to this application.
- Schedule a public hearing for this application.
