Dear Mr. Walker:

The Rhode Island Department of Environmental Management Office of Water Resources (RIDEM OWR) has reviewed the above-referenced project for compliance with the State Water Quality Regulations (§250-RICR-150-05-1). The project involves establishing a Marina Perimeter Limit (MPL) for an existing fixed dock with associated floating docks with a capacity for up to ten (10) boats, as further described in your application and detailed on site plans consisting of one (1) sheet as prepared by Carolyn J. Doyle, PE and submitted by Russell Morgan of GZA GeoEnvironmental Inc., received by RIDEM OWR on June 18, 2024. The State water associated with this project is Point Judith Pond, Class SB.

It has been determined that the above-referenced application is compliant with the requirements of the RI State Water Quality Regulations, provided that the applicant complies with the abovereferenced project application materials and the following conditions:

1) The new MPL to be established is limited to the state plane coordinate points, starting in the southwest and moving counterclockwise to the northwest, as described below:
