Dear Honorable Mayor and Members of the City Council,

At our Thursday 08 June 2024 meeting, the Newport Waterfront Commission reviewed the above application to modify/relocate an existing timber landing pier, ramp, and float. The applicant's representative was present to answer questions. The modifications would increase the size of the landing pier by about 100 sq ft. and move the float away from interfering structures by about three feet. The changes would improve safety for persons using the float, and increase the structure's resilience during unusually high tides. The Waterfront Commission voted unanimously to approve the application with the following conditions:


